### NC FFA Camp Registration

Due to the highly competitive nature of the camp registration process, the signup process for the 2022 season will transition to a lottery-based system. Advisors will have 48 hours to submit their camp request online. After the 48-hour period, each entry will receive a randomly generated number to determine the order of registration.

Allowing advisors 48 hours to submit their request should result in fewer errors than the previous method of submitting requests as quickly as possible. The extended registration period also eliminates issues with scheduling conflicts and burdens placed on single teacher programs.

The Kirkland Cottage will not be available this summer. This will reduce the number of available rooms in the lodge. Please be prepared to sleep in the cabins and dorms with your students if a lodge room is not available.

Waivers are required for all FFA members attending FFA Camp and State Leadership Conference (SLC). The paper waiver is available [online](#). Please bring two copies of the completed waiver for each student to camp. The camp director will keep one copy and the advisor will keep one copy.

A \$100 deposit is required for all student FFA members. Deposits are non-refundable and non-transferable between chapters. Deposits are not required for advisors, chaperones, guests, or advisor's children that are not FFA members. We welcome early payment of deposits. The check will be returned if your request is not honored.

**NEW THIS YEAR:** Final invoices will be sent to the advisor after check-in is complete at the NC FFA Center. Please do not bring any form of payment with you to the NC FFA Center. A single check should be mailed to the state office for the total invoice balance.

**Monday, April 25, 2022, at 3:00pm** - 100% NCATA chapters that have submitted and paid their FFA membership dues will be allowed to submit their camp request. On Wednesday, April 27, 2022, at 3:00pm, registration will close and all entries will be randomly assigned a number. Starting with number 1, chapter requests will be placed in their preferred weeks until all chapters have been placed and/or weeks are full. Chapters will be notified of their placement and must submit their student deposits within 5 business days to confirm their reservations.

**Monday, May 2, 2022, at 3:00pm** - Non-100% NCATA chapters that have submitted and paid their FFA membership dues may submit their camp request for any remaining weeks. On Wednesday, May 4, 2022, at 3:00pm, the registration will close and all entries will be randomly assigned a number. Starting with number 1, chapter requests will be placed in their preferred weeks until all chapters have been placed and/or the remaining weeks are full. Chapters will be notified of their placement and must submit their student deposits within 5 business days to confirm their reservations.

**State Leadership Conference (SLC) registration will open for all chapters on Monday, May 16, 2022, at 3:00pm.**

On Wednesday, May 18, 2022, at 3:00pm, the registration will close and all entries will be randomly assigned a number. Starting with number 1, chapter requests will be placed in their preferred SLC session until all chapters have been placed and/or the remaining SLC session is full. Chapters will be notified of their placement and must submit their student deposits within 5 business days to confirm their reservations.
