The paper waiver is available online. Please bring two copies of the completed waiver for each student to camp. The camp director will keep one copy and the advisor will keep one copy.

A \$100 deposit is required for all student FFA members. Deposits are non-refundable and non-transferable between chapters. Deposits are not required for advisors, chaperones, guests, or advisor's children that are not FFA members. We welcome early payment of deposits. The check will be returned if your request is not honored.
